# तीन तरह के विशेषाधिकार

संसद के दोनों सदनों द्वारा पारित किसी भी विधेयक को कानन बनने के लिए राष्ट्रपति की सहमति जरूरी है। बिना राष्ट्रपति की सहमति कें ये अधिनियम नहीं बन सकता है। संविधान के अनुच्छेद 11 के अनुसार, राष्ट्रपति के पास तीन तरह का वीटो पॉवर है।

1. पूर्व वीटो : इसका उपयोग केवल दो मामलो में किया जा सकता है। पहला-अगर संसद द्वारा पारित कोई विधेयक निजी है। दसरा– अगर किसी विधेयक को राष्ट्रपति की मंजूरी मिलने से पहले मंत्रिमंडल इस्तीफा दे देता है।

2. निर्लोबत वीटो : इस्तेका इस्तेमाल करके राष्ट्रपति धन विधेयक को छोड़कर किसी भी विधेयक को पुनर्विचार के लिए लौटा सकते हैं। हालांकि, संसद विधेयक को संशोधन के साथ या बिना संसोधन के फिर से पारित करके राष्ट्रपति को भेज सकती है। ऐसा होने पर राष्ट्रपति को उस विधेयक को मंजूरी देना अनिवार्य होता है।

3. पॉकेट वीटो : इस स्थिति में किसी विधेयक की न तो पुष्टि की जाती है और न ही अस्वीकार किया जाता है। विधेयक को वापस भी नहीं किया जाता है, बल्कि अनिश्चित काल के लिए अपने पास रखा जा सकता है। दरअसल, राष्ट्रपति के लिए किसी विधेयक के संबंध में निर्णय लेने की समयासीमा का उल्लेख संविधान में नहीं है। इसी का इस्तेमाल करके राष्ट्रपति किसी विधेयक को अधिनियम बनने से रोक सकते हैं। हालांकि, यह संविधान में उल्लेखित प्रावधान

# Aspire for 50% female directors at firms: Goyal

## PM to launch global bullion exchange

**FE BUREAU** Ahmedabad, July 25

PRIME MINISTER NARENDRA Modi will lay the foundation of the headquarters of the International Financial Services Centres Authority (IFSCA) on Friday at Gujarat International Finance Tec-City (GIFT City), India's only International Financial Services Centre (IFSC). Apart from building of IFSCA, the unified regulator for the development and regulation of financial products, financial services and financial institutions in IFSCs in India, the Prime Minister will launch India International Bullion Exchange (IIBX), India's first International Bullion Exchange in GIFT-IFSC. IIBX will facilitate efficient

price discovery with the assurance of responsible sourcing and quality, apart from giving impetus to the financialization of gold in India. This shall empower India to gain its rightful place in the global bullion market and serve the global value chain with integrity and quality. This also re-enforces the commitment of the Centre towards enabling the country to be able to influence global bullion prices as a principal consumer.

PM will also launch NSE IFSC-SGX Connect. Under this, all orders on Nifty derivatives placed by members of Singapore Exchange will be routed to and matched on the NSE-IFSC order matching and trading platform. The said Connect will deepen liquidity in derivative markets at GIFT-IFSC, bringing in more international participants and creating a positive impact on the financial ecosystem in the GIFT-IFSC.

Broker & dealers from India and across international jurisdictions are expected to participate in large numbers for trading derivatives through Connect. Several other key announcements will also be made during the visit of the Prime Minister.

ery of the amount. Following Justice Manjunath's untimely demise in January this year, CDELboard had on February 7, 2022 appointed Justice Nagamohandas in his place and asked him to submit a report.

"We wish to inform that the board at its meeting held today took on record the recommendation of Justice H N Nagamohandas, a retired judge of High Court of Kamataka, who recommended filing a commercial suit against MACEL for recovery of amounts by 6 subsidiaries and one joint venture of the company," said CDEL. The board has conveyed the same to 6 subsidiaries and one joint venture of the company and has instructed the subsidiaries to take the necessary steps, it added.

# IARI introduces 3 new basmati rice varieties

**SANDIP DAS** New Delhi, July 25

**BOOST EXPORT** prospects and reduce pesticide usage, the Indian Agricultural Research Institute (IARI) has this kharif season distributed seeds of three new varieties of basmati rice, which possess inbuilt resistance to bacterial blight and blast diseases. IARI, Pusa, Delhi, an insti-

tute affiliated to the Indian Council for Agricultural Research, has supplied seeds to farmers of improved PB1847, PB1885 and PB1886 rice varieties, in which two genes have been inserted, which could withstandtheattack of bacterial blight and blast diseases that adversely impact the cropyield. According to AKSingh, direc-


tor, IARI, three varieties would gradually replace the existing basmati rice varieties PB1121, PB1509 and PB6, which are cultivated in more than 90% of the about 2 million hectares of aromatic and long-grain rice-

"Existing key varieties over the years have developed resistance to bacterial blight and blast diseases, leading to excessive use of pesticides by farmers, thus increasing reports of rejection of export consignments due to presence of pesticide residue," Singh told FE.

He said field trials of new varieties were conducted at select farmers' fields last year and after getting encouraging results, the seeds for new varieties have been given to farmers for further multiplication this kharif season in key growing

areas of Punjab, Haryana and western Uttar Pradesh.

Scientists say that for managing bacterial blight disease and blast, farmers use antibiotics and fungicides, which is not a sustainable approach. There are several instances of consignments of India's basmati rice being rejected by importing countries due to presence of pesticide residue in the crop. While the high-yielding and larger-grained PB1121 variety was certified as basmati rice in 2008, the PB1509, which takes fewer weeks to mature, was released in 2013. PB6 was released in 2008.

The PB1121 and PB1509 varieties have a share of 70% in India's basmati rice exports.

"Newly-introduced basmati rice varieties are expected to hugely reduce pesticide consumption and improve the

quality of rice," Vijay Setia, former president of the All India Rice Exporters Association and an exporter, said.

Basmati rice exporters in association with the Agricultural and Processed Food Products Development Authority, have initiated outreach programmes to optimise use of pesticides by farmers.

India exported 3.9 million tonne of Basmati rice worth \$ 3.54 billion in 2021-22. Shipments to the top 10 countries — Iran, Saudi Arabia, Iraq, the United Arab Emirates, the US, Yemen, Kuwait, the UK, Oman and Qatar have a share of more than 81% in India's volume of exports of basmati rice.

According to an analysis by IARI of the economic value accrued because of basmatirice, ₹1.66 trillion worth of export earnings between 2010 and 2019 were from the shipments of PB1121 and PB1509 rice varieties, while domestic sales were to the tune of ₹51,501 crore in the same period.

After deducting the cost of production, the IARI assessment has stated that ₹1.34 trillion has been accrued as earnings to an estimated 1 million farmers in Punjab, Haryana, Himachal Pradesh, Uttarakhand, parts of Uttar Pradesh and Jammu & Kashmir, who grow two varieties of aromatic and long-grained rice.

In the global trade of basmati rice. India has a share of around 85%, while the rest is with Pakistan.

## Report: Micro finance institutions' securitisation volume more than doubles to ₹3,500 cr in Q1: Report

SECURITISATION VOLUME **ORIGINATED** by micro finance institutions (MFIs) stood at about ₹3,500 crore in the first quarter of fiscal 2023 as against ₹1,460 crore in the year-ago quarter, a report said on Monday.

Securitisation is the financial practice of pooling various types of contractual debt such as residential mortgages, commercial mortgages, auto loans or credit card debt obligations (or other non-debt assets which generate receivables) and selling their related cash flows to third party investors as securities, which may be described as bonds, pass-through securities or Collateralised Debt Obligations (CDOs).

The securitisation market is primarily intended to redistribute the credit risk away from the originators to a wide spectrum of investors who can bear the risk, thus aiding financial stability and providing an additional source of funding.

While the impact of the second Covid wave was witnessed on the asset quality of originators, no major impact was seen during the third wave that improved the confidence of the investors, the report said.

Securitisation remains a key funding tool for NBFC-MFIs, with the share of securitisation in the funding mix increasing to 27 per cent in Q4

FY22. However, this remains below pre-pandemic levels.

Icra Ratings vice president and group head (Structured Finance Ratings) Abhishek Dafria said the sector has historically shown healthy asset quality barring major events like demonetisation, and has seen robust growth in its portfolio in the period from FY19 to FY20.

After the impact of the pan demic, the sector has again shown resilience and the ability to bounce back, he said.

"Due to increased collec tion efforts, regulatory support in the form of restructuring and moratorium, and reduced concerns about the pandemic impact, investors are once again considering micro loan securitisation, particularly to support banks' priority sector lending targets," Dafria said.

Securitisation in India is carried out either through Direct Assignment (DA) transactions (bilateral assignment of pool of retail loans from one entity to another) or through the Pass Through Certificate (PTC) route (instruments issued by bankruptcy-remote trusts).
