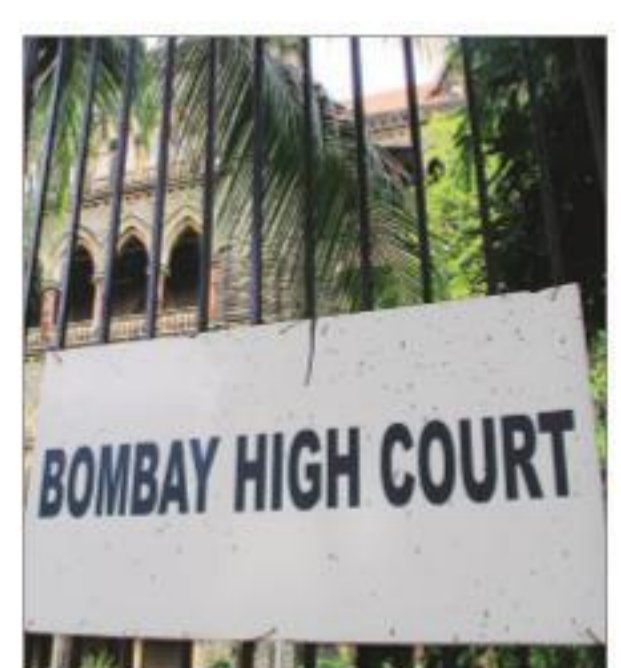

Law must go if effect illegal, govt silent why IT rules changed: HC

THE BOMBAY HIGH COURT on Thursday said if the effect of a rule or law is unconstitutional, it has to go, no matter how laudable the motive may be.

A division bench of Justices Gautam S Patel and Neela K Gokhale made these observations as it began final hearing on pleas challenging the amended Information Technology Rules that empower the government to identify "fake news" about it on social media platforms through the Fact Check Unit (FCU).



The bench also questioned the Centre's silence on the need for amended Rules - these have been challenged by standup comedian Kunal Kamra, Editors Guild of India, New Broadcast and Digital Association and Association of Indian Magazines.

According to the IT Rules amended in April this year, content marked by the FCU as "fake or misleading" will have to be taken down by online intermediaries if they wish to retain their "safe harbour" (legal immunity against third-party content).

underestimating the intellect of citizens by being the "nanny state" under the garb of shielding public from what is bad and distasteful.

Responding to Kamra's claim that the impugned Rules violated fundamental rights of citizens, the bench said, "No matter how laudable or high the motives are, if the effect is unconstitutional then it has to go."

The bench said that while the Centre said that the PIB has existed for a long time to keep a check on fake news, it could not explain whether the existing mechanism was inadequate and what was the need for the FCU.

The bench questioned whether the mechanism of the Press Information Bureau (PIB), that has been in existence for long, is so inadequate that it requires an amendment to include the FCU.

"Whenever PIB issues a clarification, every news channel and paper carries it. Where do we find explanations in replies (by authorities) as to why that structure is inadequate and why you (government) need (an) amendment? Affidavit filed by the Centre is silent on it," Justice Patel said.

"This is actually the case because you do not understand the extent of the realm, reach and power of technology. This would not have been necessary in case of print. You just do not understand what the Internet can do. Governments cannot do away with the Internet as that is where they carry out their business. But it comes with its limitations. This is more like the fear of the unknown. And this is why the government has come up with this (FCU). Whether it is legitimate or not is what we have to decide," the bench said.

Kamra's plea challenged Rule 3 (1)(ii) (A) and (C) of the IT (Intermediary Guidelines and Digital Media Ethics Code) Amendment Rules, 2023, stating that this would, in effect, amend Rules 3 (1)(a) and 3 (1)(b) (v) of the IT Rules, 2021, violating several Supreme Court judgments.

Last month, the Centre told the bench that identification of misleading or false content by the FCU of the Ministry of Electronics and Information Technology (MeitY) would not lead to its automatic taking down; the aggrieved party would be entitled to pursue legal remedy and the competent court would be the final arbiter in the matter.

"When ever PIB issues a clarification, every news channel and paper carries it. Where do we find explanations in replies (by authorities) as to why that structure is inadequate and why you (government) need (an) amendment? Affidavit filed by the Centre is silent on it," Justice Patel said.

"This is actually the case because you do not understand the extent of the realm, reach and power of technology. This would not have been necessary in case of print. You just do not understand what the Internet can do. Governments cannot do away with the Internet as that is where they carry out their business. But it comes with its limitations. This is more like the fear of the unknown. And this is why the government has come up with this (FCU). Whether it is legitimate or not is what we have to decide," the bench said.

On Thursday, Senior Advocate Navroz Seervai, representing Kamra, claimed that the Rules were amended by the government to show "it is my way or the highway". He said the government, in a way, is saying that it will ensure that social media covers only what it wants and everything else is censored.

"It wants to take the role of parents n nanny of the public," Seervai said, adding that the petitioner did not understand why the government was

Seervai said the government cannot act as a judge to ascertain veracity of any information available on social media, where some people including satirists, journalists have been shunned for airing their views.

He said that the intermediaries, which are big corporations, are not concerned with the information they host.

India signs MoU with Tanzania to set up IIT-M campus in Zanzibar

SETTING THE BALL rolling for IIT Madras's global campus to start operations this year, India signed a Memorandum of Understanding with Tanzania on Thursday to establish the first IIT branch abroad, in Tanzania.

The IIT Tanzania campus is expected to open in October this year, welcoming 50 undergraduate and 20 master's students in its first batch.

Indian Express, IIT Madras director VKamakoti had said that IIT Tanzania will be a branch of IIT Madras. "Our criteria for establishing campuses abroad include demand for an IIT in the country, support from the host government, and a strong school education system that cultivates talented candidates," Kamakoti had said. "Tanzania meets all three requirements, with an exceptional education system and the potential to attract outstanding candidates. We anticipate that IIT Tanzania will draw students from across Africa."

The agreement on Thursday was signed between the Union Ministry of Education, IIT Madras and Tanzania's Ministry of Education and Vocational Training Zanzibar. In a tweet on Thursday, External Affairs Minister S Jaishankar thanked President of Zanzibar Hussein Ali Mwinyi for being present during the MOU signing, which he said reflects "India's commitment to the Global South."

Education Minister Dharmendra Pradhan tweeted, "The initiative is an embodiment of PM @narendramodi's commitment to strengthen South-South cooperation as well as forge stronger people-to-people ties with Africa."

IIT Madras is expected to launch four undergraduate and five post-graduate programmes from the Zanzibar campus. While IIT Madras will have the last word on academic programmes, curricula and student selection criteria, the capital and operating expenditure will be met by the government of Zanzibar-Tanzania, the MEA said in a statement.

Students graduating from this campus will be awarded IIT Madras degrees.

Besides Tanzania, two more global campuses of IIT Delhi and IIT Kharagpur are set to come up in Abu Dhabi and Kuala Lumpur.

FREEDOM OF EXPRESSION cannot be used for "legitimising violence", India said on Thursday in response to media reports citing comments by Canada's prime minister on Ottawa's handling of supporters of a separate state for the Sikh community.

India summoned the Canadian envoy in New Delhi to register its protest after Indian media reported that posters issued for rallies there and in Britain by the Sikh group's supporters also targeted Indian diplomats, a foreign ministry spokesperson said.

"The matter has been strongly taken up with Canadian authorities, both in New

"Posters inciting violence against diplomats and our diplomatic premises are unacceptable, and we condemn them in the strongest terms," Canadian Prime Minister Justin Trudeau was quoted by media as saying that India was "wrong" to suggest he was soft on the protesters.

He said that there is freedom of expression, "but we will always make sure that we are pushing back against violence and extremism in all its forms."

Bagchi said that the "issue is not about freedom of expression. But its misuse for advocating violence, for propagating separatism and for legitimising terrorism."

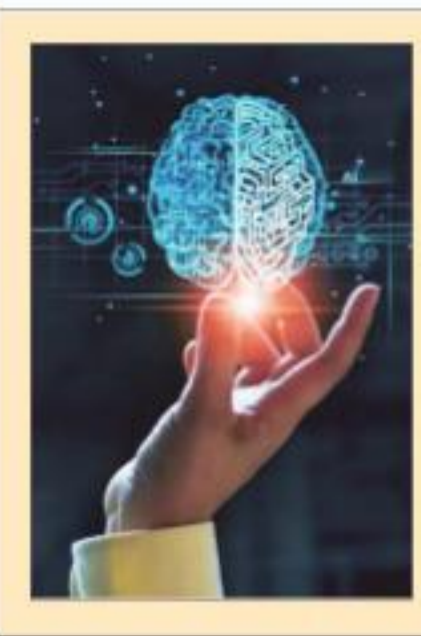

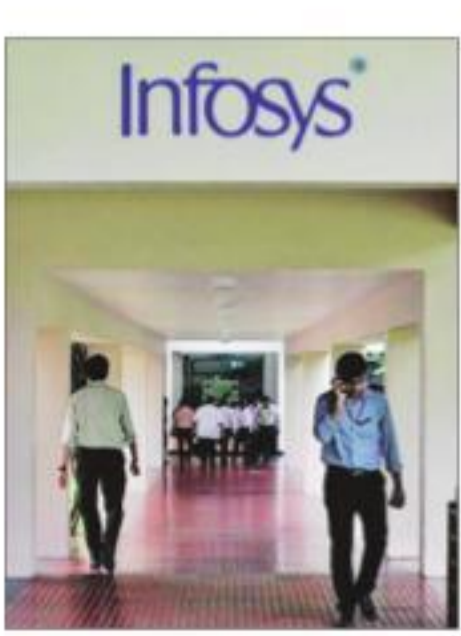
